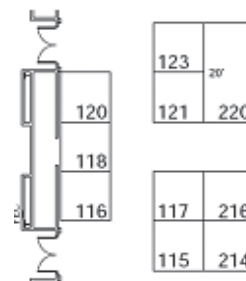

IMPORTANT TIPS:

- NOTE: There are THREE floor plans contained in this exhibitor prospectus. Be sure you indicate the booth numbers above with the correct floor plan.
- Please familiarize yourself with the orientation/entrance into each hall. Some plans may include more than one entrance.
- Spread your booth choices throughout the exhibit hall...not everyone can be by the front door.
- Booth Definition:
 - An inline booth is a booth that can only be approached from one side (such as booth 118).
 - A corner booth is a booth that can be approached from more than one side (such as booth 117).
 - If you wish to buy a booth but don't see a "clear configuration" of the size you want, you can take small booths to create a bigger one. For example, 10x20 corner/corner booth can be created by taking 10' corner booths (such as booth 115 and 117)

EXHIBITION POLICIES

National Association of Mortgage Brokers (NAMB) shall regard this document, upon receipt at NAMB headquarters, as a formal application on the part of the forwarding company to participate in the 2008 Annual Convention, NAMB/SOUTHEAST and/or NAMB/WEST in the capacity of Exhibitor. Further, the forwarding company agrees to accept any allocation of booth space as deemed appropriate by the NAMB Meetings Department in accordance with the booth selection process as stated in Exhibitor Prospectus. All correspondence and inquiries originating from NAMB shall be directed to the individual listed on this form as the company contact. It is this individual that NAMB will designate as the official company representative through whom all correspondence will take place and who principally will be responsible for the prompt and complete payment of all fees due to NAMB.

ASSIGNMENT OF SPACE

Booth space will be assigned at the discretion of NAMB with due regard to the history of support for the Association. For 2008 Annual Convention and NAMB/WEST it will include companies in the Industry Partner program (IPs), sponsors and 2007 Annual Convention and/or NAMB/WEST exhibitors. For NAMB/SOUTHEAST, the order will include IPs, sponsors and 2007 Annual Convention exhibitors. In the event of competing requests for booth space convention sponsorship status will be taken into account in the assignment of booths. Assignments will be made on the following schedule:

CANCELLATION & REFUND POLICY

Notice of cancellation must be made in writing (no exceptions) and sent to Jason Hawthorne Petty in the Meetings Department at NAMB. Cancellations received by 5p.m. EST, Friday, February 1, 2008 (Annual Convention); Friday, March 28, 2008 (NAMB/SOUTHEAST) and Friday, June 27, 2008 (NAMB/WEST) will be refunded 50% of the cost of the booth or 50% of the deposit already paid, (whichever is less.) After the signing of the Rental Agreement, a decrease in exhibit space is considered to be the equivalent of a cancellation. Exhibitors will be held responsible for the original terms of the agreement. Cancellations made after this date will receive no refund.
